

RESOLUTION

Authorizing and directing the Committee on the Judiciary to investigate whether sufficient grounds exist for the impeachment of Donald John Trump, President of the United States.

- 1 *Resolved*, That the Committee on the Judiciary, acting as
2 a whole or by any subcommittee thereof appointed by the
3 chairman for the purposes hereof and in accordance with the
4 rules of the committee, is authorized and directed to
5 investigate fully and completely whether sufficient grounds,
6 including but not limited to:
- 7 (1) obstruction of justice;
 - 8 (2) violations of the Foreign Emoluments Clause and
9 Domestic Emoluments Clause of the United States
10 Constitution; and
 - 11 (3) conspiring with others to:
 - 12 (a) commit crimes against the United States
13 involving the solicitation and intended receipt by the
14 Donald J. Trump campaign of things of value from a
15 foreign government and other foreign nationals; and
16 (b) conceal those violations;

1 exist for the House of Representatives to exercise its
2 constitutional power to impeach Donald John Trump,
3 President of the United States of America.

5 SEC. 2. (a) For the purpose of making such investigation,
6 the committee is authorized to require—

7 (1) by subpoena or otherwise—

8 (A) the attendance and testimony of any person
9 (including at a taking of a deposition by counsel for
10 the committee); and

11 (B) the production of such things; and

12 (2) by interrogatory, the furnishing of such
13 information;

14 as it deems necessary to such investigation.

15 (b) Such authority of the committee may be exercised—

16 (1) by the chairman and the ranking minority
17 member acting jointly, or, if either declines to act, by the
18 other acting alone, except that in the event either so
19 declines, either shall have the right to refer to the
20 committee for decision the question whether such
21 authority shall be so exercised and the committee shall be
22 convened promptly to render that decision; or

1 (2) by the committee acting as a whole or by
2 subcommittee.

3 Subpoenas and interrogatories so authorized may be issued
4 over the signature of the chairman, or ranking minority
5 member, or any member designated by either of them, and
6 may be served by any person designated by the chairman, or
7 ranking minority member, or any member designated by either
8 of them. The chairman, or ranking minority member, or any
9 member designated by either of them (or, with respect to any
10 deposition, answer to interrogatory, or affidavit, any person
11 authorized by law to administer oaths) may administer oaths
12 to any witness. For the purposes of this section, "things"
13 includes, without limitation, books, records, correspondence,
14 logs, journals, memorandums, papers, documents, writings,
15 drawings, graphs, charts, photographs, reproductions,
16 recordings, tapes, transcripts, printouts, data compilations
17 from which information can be obtained (translated if
18 necessary, through detection devices into reasonably usable
19 form), tangible objects, and other things of any kind.

20 SEC. 3. There shall be paid out of the applicable accounts
21 of the House such sums as may be necessary to assist the
22 Committee on the Judiciary in conducting the inquiry under

- 1 this resolution, any of which may be used for the procurement
- 2 of staff or consultant services.
